Chairperson's Message

2020 has been unlike any other year in the history of the Umbrella for the amount of disrupted service to families. It began in late January and February with the Umbrella needing to quickly arrange for full day care for school-aged children as a result of three rotating elementary teacher strikes. Then on March 14 all child care centres and school-aged programs were closed as part of a province-wide lockdown because of the pandemic caused by COVID-19. Programs did not begin to reopen again until July 13 and all staff were finally recalled by August 24. Because of COVID-19 restrictions, school-age programs were closed again for the November PA day and only reduced programs provided over the Christmas break.

For parents this year was a challenging time. Programs were closed with little notice, leaving parents without the support they were accustomed to. When programs reopened there were often bewildering Public Health requirements, often different than those requested by the schools. Because schools were completely closed for several months, Umbrella found itself unable to provide care that was needed. Umbrella was proud to use this time to improve online communications with parents, and introduce a video showing how centres were improving health and safety for children during COVID-19.

Staff struggled too with their need to care for their own children and with stress over potential infection especially if they had pre-existing health conditions. Plans were made, only to be revised many times because of new government restrictions and health guidelines changing at short notice. As a result, many staff had to work late into the evening, or on weekends, communicating with parents. Additional paperwork was added: at one time there were three separate reports to be filled out for each child who was excluded under Public Health guidelines. Requirements to wear PPE all day added to staff exhaustion. Umbrella was proud to be able to maintain all previous pay levels throughout the entire period using funding from the Federal government (including the CERB and CEWS) and from the supportive

Hamilton Children's Department who continued to provide funding. It was also pleased to be able to offer substantial health and safety training for all, additional staff development, small tokens of appreciation, and some additional remuneration.

Our Board members provide loyal service to the Umbrella. We thank Heather Beckley for her committed service and we accept her resignation from the Board with sadness. Heather was a strong advocate for parental issues, and advocated for the use of the Storypark software to improve parent engagement with their children in our centres, which was introduced this year. I would like to thank Farzana Reburiano, Igor Rustic, and Diana Furry who chaired the Finance, Governance and Membership committees. Many thanks to Freda Vanopoulos, Diana Furry, Farzana Reburiano, Ted Cambridge, Igor Rusic, Helen Benoit and Jeff Boyle for being willing to sit on the Umbrella Board this coming year, and for their continued hard work and commitment to the Umbrella.

Times of crisis show the real mettle of an organization. Team work and commitment to the service of children have been amply demonstrated. Staff have been shown they are valued. Our staff, including our professional Early Childhood Educators, who are the backbone of our organization, have risen to the considerable challenges of the year. We are grateful for all their contributions and the energetic leadership of our Executive Director, Darryl Hall and the Administrative team. Thank you all for your part in making the best of what has been a very difficult year.

I am so grateful to work for an organization like the Umbrella. Our volunteer Board of Directors provided steady leadership when there were so many unknowns. The kindness and compassion that has been displayed by our staff, children, and families during this time has been an inspiration.

Let me add a personal note. Like many of you, I also have a family to worry about. I am an Umbrella colleague, but also a father, a husband and a son. At times like these, the worry list can be long for all of us, there are no exceptions. I am also convinced we have, and will continue to get through this together. Please stay safe and focus on what's most important. That is, the well-being of yourself, your family, and our community.

March

Global Pandemic

COVID-19 causes an unprecedented shutdown of child care centres in Ontario.

Professional Development

The closure provided an opportunity to invest time and energy into the Professional Development of our educators, covering a variety of topics such as:

- training on the new Public Health requirements
- program planning within the new restrictions
- engaging in reflective practice

This was not only beneficial from a learning aspect, but to ensure that we stayed connected and continued to build relationships with our educators remotely.

Pandemic Plan and Return to Care Video

To open our doors again safely, Umbrella developed a comprehensive "Pandemic Operating Plan" to cover new policies and procedures based on Public Health guidelines to keep children and staff as safe as possible. Knowing that many parents were anxious about returning to child care, a video was created to help explain the safety precautions being taken as we re-opened after the closure.

Virtual Tours and Play Visits

As child care began to open again, it was very important to us that we not only invited new children into our programs, but that we included parents as partners in their child's care and that everyone felt safe, supported and had a sense of belonging when beginning in one of our programs. We prepared and implemented a detailed plan outlining a new step-by-step process that all of our programs would follow when welcoming a new child into one of our programs including:

- a "virtual tour" with pictures showing each area of the centre
- zoom meetings for parents and children to meet the staff and exchange pertinent information
- pictures of what staff look like with PPE on and what they look like underneath
- socially distanced in-person play visits at the end of the day out on the playground

Re-Opening Child Care Centres

Not only did policies need to be updated but our communication methods and the system of how we received requests for child care had to be swiftly adapted from paper solutions to digital ones. We launched our online Parent Portal to be able to process registrations as we re-opened in July. This system also functions to collect verified email addresses so we can communicate with parents quickly and effectively.

New Materials and Equipment

We have always known that children of all ages benefit significantly from outdoor experiences, but COVID-19 has reinforced the importance of outdoor play. The safest place for children to be is outdoors where there is natural ventilation, and they have lots of space. "Muddy Buddies" were purchased for our infant, toddler, and preschool children so that they could explore all elements of nature, regardless of the weather. Portable outdoor equipment carts with over 50 pieces of openended materials were ordered for each school age cohort. Children were able to use these pieces of equipment for gross motor activities, imaginative play, and to set up outdoor cozy areas for solitary experiences (reading, relaxing, yoga, etc.) The possibilities have been endless!

We would like to thank the City of Hamilton for the funding Umbrella received to support the purchase of these items for our child care programs.

Umbrella made the decision to invest in "Storypark", an online application to document and support children's learning and engage families in their child's progress and development. As families interact with Storypark, their feedback and participation becomes a conduit for further learning and ensures that parents are included as the most valuable resource in a child's learning journey. We have heard repeatedly since the re-start of our programs in July that parents feel disconnected from their children's learning as they have limited contact with educators and cannot physically enter the centre. We know that Storypark has helped bridge this gap already and are looking forward to bringing all of our centres onboard by the end of 2021.
